ALL ENTRIES MUST BE POSTMARKED BY July 15, 2016 IN ORDER TO PARTICIPATE.

To be eligible for Evaluation, a Fjord must:

- Be owned by a current NFHR member.
- Be registered with the NFHR.
- Have been DNA typed (geldings included).
- Be microchipped and recorded with the NFHR.
- Have a current (within 30 days) Veterinarian Health Certificate.
- Have a negative (within one year of eval date) Coggins report.

The DNA typing kits and microchips are available from the Registrar, Jeanne Poirier. Please contact her if you have questions regarding your Fjord's status on any of the above items. Jeanne's phone number is 303-684-6466 and her email is jeanne@nfhr.com.

CAMPING:

STABLING:

Stabling fee: \$25/night. Please pre-arrange additional nights beyond Friday and Saturday. This includes a departure stall clean-out, and shavings upon arrival. Additional shavings will be available for purchase at \$7/bag. Daily cleaning is the responsibility of the owner. Please bring your own mucking tools. All stalls will be pre-assigned and sent to owners. Tack stalls are available for \$15/night.

SCHEDULE OF EVENTS:

Prior to the event, a final schedule and stall assignment map will be emailed to all participants. Upon your arrival you will be given your entry packet. The packet will include your stall assignment, map of the fairgrounds, bridle tag number and program. The Evaluation will begin Friday morning, August 19th with conformation tests and some performance tests. The remaining Performance tests are scheduled for Saturday and Sunday, August 20st and 21st. The number and type of entries will determine the final schedule.

Early Friday morning, there will be a meeting of the participants, TD and Evaluators. This is primarily an informational session to review the day's schedule and answer any questions.

Format for the evaluation will be: Test, ribbon presentation and evaluator comments for that test. There will be a lunch break both days. Medallion of Quality presentation will be on Sunday, after the last performance test, ribbon presentation and evaluator comments are completed for that test.
