#### **EDUCATION COMMITTEE-Cynthia Madden**

**Objective:** Provide educational opportunities to NFHR members and to the public and facilitate promotion of the Fjord Horse.

#### Highlights of 2016:

In 2016 a lot of effort was put into the planning of the 2017 NFHR Form to be held in the Ballard neighborhood of Seattle, Washington at the Nordic Heritage Museum and other locations on January 28th and 29th. Board members, Eric Watness and Gretchen Payne, have spearheaded the planning along with members of the Pacific Northwest Fjord Promotional Group. Thanks to the PNFPG for their planning, logistical and financial support. A new brochure on "Finding Your Norwegian Fjord Horse" was approved and will be available for download from the NFHR website. The "New Owner's Guide" was revised and updated and the board suggested that the Guide be made available to NFHR regional clubs for distribution at their discretion. Kay Schwink has authored a series on "Feeding Your Fjord". Part 1 appeared in the Fall 2016 Fjord Herald issue. These articles are in response to a desire by members for more nutrition information as indicated in the 2015 Member Survey. We hope to reprint the resource guide in 2017 with the help of the Fjord Foundation.

## **ELECTIONS COMMITTEE-Bob Long**

**Objective:** Solicit and accept nominees for the Board of Directors and conduct elections.

## Highlights of 2016:

The entire Board essentially acts as the Elections Committee. Though we advertise heavily in the Herald and Constant Contact for members to run for the Board, it is often word of mouth and personal knowledge that have the best result in getting interested members to apply. The job is a demanding one and your Board are all volunteers, so it is difficult to both enthusiastically recruit interested members and at the same time, not sugar coat the accompanying responsibilities.

The qualifications are simple – a member in good standing of the NFHR for the previous two years, ownership of an NFHR registered Norwegian Fjord Horse, and a promise to abide by the By-Laws, Rules of Registrations and Transfers and Ethics Policies of the NFHR. Added to this would be willingness to fully participate in the Board meetings, and in NFHR committees, and attend one Face to Face Board meeting each year. ## **EVALUATION COMMITTEE-Eric Watness**

**Objective:** Ongoing development and oversight of the NFHR evaluation program with emphasis on Evaluator and TD Training Program.

# Highlights of 2016:

Evaluation Committee (EC) members Dan Watanabe, Lori Albrough, Wendy Bauwens, Ardeth Obenauf, and Brandy Ferganchick met in two teleconferences along with Eric Watness, EC committee chair and Jeanne Poirier, Registrar and Technical Delegate, to recommend and implement potential revisions to the NFHR Evaluation program. The first meeting focused on the status and history as well as issues and concerns about our existing program. The participants divided into subgroups to circulate an informal questionnaire to three groups of NFHR members: evaluators, horse owners and breeders. The purpose was to determine interest in the current program and learn member views of positives and negatives with our evaluation system. Thereafter, a questionnaire was distributed resulting in receipt of a number of significant responses. Those responses were summarized and disseminated to other committee on evaluations to meet in person and to discuss potential revisions and viewpoints expressed in response to the questionnaire. While the original goal was to make final EC recommendations to the BoD by September 1, 2016, the select committee was not able to meet until January, 2017. That group did meet as planned and will make general and specific recommendations to the BoD at the 2017 F2F for implementation by the EC in 2017.

# FINANCE COMMITTEE – Cynthia Madden

**Objective:** Coordinate with the Treasurer and Executive Director to manage the finances of the NFHR.

# Highlights of 2016:

The NFHR experienced a negative balance in yearend numbers due to advance payment of expenses for the 2017 NFHR Education Forum and Face to Face Board Meeting. A continued decrease in membership and foal registrations are also responsible for not having the desired healthy final balance. Ownership transfers experienced a drop after having a better year in 2015. It was decided at the 2016 Board of Directors Face to Face meeting that all future member donations be kept in a separate bank account to ensure their availability for member designated purposes. This has been successfully implemented. Our Executive Director and Registrar continue to run our Berthoud office very cost efficiently. They are a most valuable asset to the NFHR. With appointment of a new Editor, Erin Kinn, the "Fjord Herald" has improved its financial picture while maintaining quality and appeal. Publishing cost savings were realized in 2016 and will improve even more in 2017. Wendy Bauwens ran a very successful Evaluation in Bozeman in August which created a model for fundraising for evaluations. The results for 2016 are disappointing but not insoluble. To ensure the US Fjord Horse's viability we must become more creative and assertive in marketing our breed and pursue an improved understanding of the needs of our membership. While the international Fjord industry overall is suffering from a drop in new births and sales, the NFHR needs to address these issues aggressively to preserve the Norwegian Fjord Horse in the United States.

# FJORD HERALD COMMITTE-Gretchen Payne

**Objective:** Assist the *Fjord Herald* Editor to obtain, solicit, and generate content for the *Fjord Herald* issues to include advertising, articles and photos.

## Highlights of 2016:

2016 was a new, huge year for the NFHR Fjord Herald. May 2016 marked the resignation of editor Beth Beymer and the introduction of our new editor, Erin Kinn. Erin brings forth a wealth of publication experience, including graphic and technical editing, layout design, and advertising. Based on her expertise, the Herald and Executive Committees agreed to consolidate the positions of Editor and Graphic Layout into one = Editor. The basis of this decision was:

- The costs of print and postage have risen steadily over the years. The Herald costs were outweighing the profit for the NFHR.
- Consolidating two individual positions into one position presented a substantial cost-savings for the NFHR. This has dramatically offset the cost of print and postage.
- The single job of Editor has streamlined the communication and construction process for the publication. Communication is now directly through the Editor to the Committee without a middleman or delay.
- Production time has been expedited.

It is the duty of the Herald Committee to support the Editor and assist as needed regarding press material, advertisers, Fjord-related topics, and final production. This is facilitated through the use of the Basecamp program in which files are organized and discussed. The benefit of this platform, is having an electronic "database" for each Herald and the articles/photos that are included in each issue. This database is then available to Herald Committee members and future editors for years to come.

## PROMOTIONS AND MARKETING COMMITTEE-Nancy Grette, Cynthia Madden

**Objective:** To promote the Norwegian Fjord Horse and the Norwegian Fjord Horse Registry and assist NFHR members in marketing their Fjord Horses.

#### Highlights of 2016:

The NFHR office continued to send out promotional materials and the NFHR display to those requesting them for events such as expos and fairs. The ZAZZLE.Com NFHR Marketplace site had several new logo items added and we continue to sell NFHR logo items from the NFHR Marketplace site on our website. We are looking for someone with the knowledge to manage and promote the Zazzle site to members. Wendy Bauwens created and distributed a Fjord Horse poster and conducted an advertising campaign to promote the Bozeman evaluation. To ensure the US Fjord Horse's viability we must become more creative and assertive in marketing our breed and pursue an improved understanding of the needs of our membership. # Highlights for 2016:

The Youth Committee ended 2016 with a total of 5 youth memberships.

I have been involved with the Youth Committee for several years and what I have noticed from the start, is the lack of attention and focus this committee receives from our membership and the public in general. I feel very passionate about this committee and the importance of continuing to support and encourage our youth with the Fjord breed. However, the support has just not been there.

I would like to suggest the following for the Youth Committee:

- Start a new public campaign to solicit support and new youth memberships (to be done through the Herald, Constant Contact, Website, and Facebook)
- Reach out individually to organizations that currently have Fjords in their programs such as therapy centers, riding instructors, breeders, and trainers. Encourage them to spread the word about the NFHR and about getting their young rides and Fjord enthusiasts to become involved as a Youth member. Perhaps an incentive can be extended for those who are willing to assist in encouraging Youth memberships.
- Consider partnerships between associations that have Fjord participation (Pony Club, USEF, 4H, etc.)
