2024 Annual Membership Meeting Apology

The NFHR Board of Directors (BOD) would like to thank the members who attended the annual membership meeting via Zoom on January 17. We understand there were some issues with admittance to the meeting for some members. It is important to understand that to attend NFHR member-related on-line meetings, your identity must be able to be confirmed by the Registrar. A first and last name are the minimum requirement to confirm your identity. The meeting agenda did contain the requirements for joining the meeting:

All members must be current and identifiable by their Zoom alias. You will not be allowed in the meeting if we cannot verify who you are.

We also understand not everyone has renewed their memberships for 2024. Per the renewal letters that were sent out in the later part of 2023, renewals were due by December 31. However, the by-laws currently allow for a grace period until February 1. From the by-laws *Article IV. Membership Section C.5*: *Membership rights are suspended automatically for any members*

whose dues have not been paid by February 1st of the calendar year. For this oversight by the Registrar and BOD, we offer our sincerest apologies to those members who were denied admittance to the membership meeting. Cherrie seconded. 7 ayes. Motion passed.

Attachment 2

Article IX – Castration of a stallion or colt Change of Reproductive Status A.

B. The Norwegian Fjord Horse Registry allows a breeder or owner of a mare, during time of ownership, to restrict the production of registrable offspring by filing a Change of Status report, which will change the registration number from XX-XXXX-M to XX-XXXX-MG. A mare designated MG is not eligible to produce registrable offspring. A reason for restricting reproduction will be recorded in the pedigree notes section at the time of requesting a change. Future owners of the mare may be granted reinstatement of breeding rights of that mare, with written permission provided to the NFHR from the prior owner(s) party that induced the restriction initially. A mare designated MG is not eligible to produce registrable offspring. If the restricting party is deceased or mentally incapable of decisions, the NFHR can be petitioned by the current owner to reinstate breeding rights, at the discretion of the BOD. There is no fee for this service.

Black sections were presented to the NFHR members in 2022. Comments were received and Cherrie addressed them in the points below, and suggested the red sections in the above proposed policy in 2023.

I think many of the membership concerns expressed are related to some misunderstandings of the proposed option for mare owners and is wrapped up in the alarmist drama on social media in 2021-2022. Below, I address those, and give an example of a relevant situation for which this policy was proposed.

- 1. This rule was primarily proposed to help reduce the 'buyer beware' aspect of purchasing a broodmare prospect.
 - a. We as a Registry want new Fjord breeders to have successful experiences with breeding. It's incredibly frustrating to a new breeder when they invest in a horse that has expensive reproductive problems. Many quit or switch breeds.
 - b. Sellers do their best to find good homes for their horses, but there is always the possibility that a flipper will buy one and resell it to a naïve buyer who doesn't do their homework on the history of the horse, and pays a lot of money and invests years trying to produce foals from that mare.
 - c. Since Fjord broodmare prospects are in high demand, their price is high and a flipper has a financial incentive to not tell the new buyer that the mare had reproductive problems.
- 2. The intent of this rule change proposal is to help the breed produce naturally fertile and healthy Fjords that are an asset to the breed for generations to come and help buyers of mares avoid purchasing lemons.
- 3. A mare can **only** be restricted for producing future registered offspring by the **current owner**, not by any prior owners or the breeder if that breeder or prior owners no longer owns the mare.
- 4. The restriction can be withdrawn by the person who imposed it. It is not permanent. The breeder and any other prior owners have no say in the Change of Status owner granting rights for producing registered offspring back on the mare, to the current owner.
- 5. People reduce the gene pool every time they geld a colt or stallion, and that change is permanent, while this rule does not result in permanently physically altering the mare.
- 6. Laparoscopic spaying is possible these days, but is commonly used to create 'teaser mares' for AI collection because a fixed mare always behave as in heat and receptive to a stallion. This is a different behavior than gelding a colt.
- 7. I know of no good reason to permanently alter a mare that one day new information could be provided that would justify her contributing to the future Fjord population? Placing a breeding restriction is not permanent like a spay surgery.
- 8. You mentioned credentials for a person deciding to limit a horse's ability to reproduce. What knowledge and qualifications are needed for an owner to geld a colt or stallion? This is commonly done by any average, unvetted horse owner, and those owners are just as capable of making a similar, yet not permanent, decision for a mare, with this proposed policy.
- 9. This proposed option for mare owners has nothing to do with the politics on the Board.
- 10. This proposed rule respects breeders and owner's recognition of breed quality, and gives an option if something is discovered about a mare that would indicate that she is not of sufficient quality to justify contributing to the future Fjord population.
- 11. A mare that receives this designation will invariably be of lower value at sale time, vs if she was allowed to produce registered offspring, so it is the rare Fjord owner who would impose this restriction on a mare they own and/or plan to sell. Most people selling Fjords are trying to get as much money from the sale as they can. There's no judgement in that statement; it's just reality. This restriction would reduce a mare's sale price, so the likelihood of this being applied to a lot of mares is very low.
- 12. Any mare that receives this designation will have a permanent note placed in her pedigree file in the NFHR database, detailing the reason(s) behind the restriction.
- 13. The reason for giving a mare the breeding restriction is not a confidential matter, so anyone can ask the Registrar for the reason behind the restriction.
- 14. Very few Fjords are evaluated these days. Hopefully that will change in the future, but some problems with a mare that would justify a breeding restriction are not things that would be noticeable at an Evaluation.
- 15. As an example, say Breeder Karin bought a mare, bred her and found out that had short (10 month) pregnancies and failed to lactate, so the foals had to have supplemental feeding. This happened in 2 successive pregnancies. All other mares managed in the same way had no

problems. Domperidone and hormones were given to the mare to induce lactation, but that also failed. Karin and her vet felt that this was an issue with this particular mare's reproductive ability and not a management issue.

- a. Many reproductive problems are heritable, and this one makes producing a foal much more expensive, so it is possibly best that mare doesn't get used as a broodmare in the future.
- b. Say Karin sold the mare for a low price (due to the reproductive problem), with full disclosure of the problem, to a home that she had confidence would not flip the mare without disclosure of the lactation problem to the next owner, and who won't try to breed the mare. That person sells the mare anyway, without the disclosure, and a new Fjord breeder buys her hoping to start their breeding herd.
- c. Most Fjords do not have reproductive problems, and that is partly because the selection historically was for horses that were functional and low-maintenance in everything, including reproducing. Many other breeds of horses have more reproductive problems than Fjords, and it's typically because they keep breeding mares that have those problems and passing the traits to the next generation. It's important to breed for the best in the future generations, and not pass bad traits to the next generation. If Fjord breeders use sub-fertile mares, or mares with other reproductive problems for producing more Fjords, that will reduce the reproductive success of the breed as a whole. Fjord Horse International is currently conducting research on the stallion lines with subfertility problems, so this is not a too-far-fetched example.
- d. Say Karin had filed a Change of Status Report for that mare before selling her, and the mare ends up in a couple more homes down the line.
- e. Say the fillies that did get produced earlier by Karin are bred and those mares don't have lactation or other reproductive problems because the stallion's genetics for fertility were good and overcame the problems from the mare in their offspring. This genetic mixing happens in every breeding, but not all problems are fixed by the other parent.
- f. If there's evidence that the offspring of that mare are not having lactation problems, or passing the undesired trait to future generations, and that was the concern that Karin had and why she imposed the breeding restriction on the mare, the current owner of the mare could ask Karin to restore the ability of that mare to produce registered offspring, and Karin could provide a letter to the NFHR asking for reinstatement of original reproductive status for the future life of that mare.
- g. Karin cannot later choose to reinstate the restriction on the mare if she does not own the mare at that time.
- h. The current owner of the mare, or a future owner of the mare can reinstate the restriction.
- i. If Karin dies and the current owner wants to reinstate the ability to register offspring from that mare, the current owner can ask the NFHR Board of Directors to grant that change of status and the BOD can make that decision.
- 16. This example lactation problem could be replaced with any of many problems that are not readily visible when looking at a mare but that are heritable. Examples include dominant inheritance of cleft palate, foals with umbilical or scrotal hernias, severe parrot mouth or monkey jaw, twins, insufficient or excess hormones, infertility, etc). These would not be identified in an Evaluation inspection.
- 17. The NFHR is not imposing mare breeding restrictions on any mare owner or mare. This would be something a mare owner would elect to do of their own volition. It is a voluntary option, not a requirement.
- 18. Are there examples of where a particular breeder may choose to apply this restriction to mares that don't have problems? Of course. But those reasons will be recorded and will be public record. Most breeders would receive so much backlash from doing this that they would not likely restrict many mares. Buyers would go to other breeders if a breeder was trying to restrict the market. No one breeder in the NFHR has control of more than 20% of the foals produced annually and that number will decrease as more breeders are recruited.
- 19. We'd like to help more breeders have successful breeding operations to keep this number increasing. This proposed rule would not hinder the production of more registered Fjords, but it could possibly help the future Fjord population to have fewer health or other problems.
- 20. If a mare has this restriction placed on her for a legitimate reason, it's unlikely that a future owner would want to waste their time and money using her for crossbreeding. A mare that can't lactate is just as big a problem to a cross-breeder as to a breeder of registered Fjords.
- 21. Contracts can work for the first sale of a reproductively unsound (or otherwise unsuitable for production of registered offspring) mare, but if the new owner doesn't pass the information on to the next owner, the due diligence of the first owner doesn't help future owners.
- 22. The NFHR will not mitigate disagreements between members, so this is for members to work out between themselves.
- 23. It was advised during the zoom meeting on this topic to remove any mention of mental incapacity, and only give reinstatement rights to the NFHR BOD when the restricting owner had passed away. That can be done with this rule.

Change of Status proposal 2024:

After our discussion on this attachment 12 proposal, I drafted a couple sentences to attempt to provide guidance on what is acceptable and what is not for this MG designation. See bold type below. I'd definitely like more input on that, to prevent this from being misused.

Article IX – Castration of a stallion or colt Change of Reproductive Status A.

B. The Norwegian Fjord Horse Registry allows a breeder or owner of a mare, during time of ownership, to restrict the production of registrable offspring by filing a Change of Status report, which will change the registration number from XX-XXXX-M to XX-XXXX-MG. A mare designated MG is not eligible to produce registrable offspring. A reason for restricting reproduction will be recorded in the pedigree notes section at the time of requesting a change.

Eligible reasons may include health, reproductive or other concerns that protect the breed viability and are intended to inform all future owners of the concern(s). The MG designation may not be used for temperament, marketing, value-proving, or other business reasons.

Future owners of the mare may be granted reinstatement of breeding rights of that mare, with written permission provided to the NFHR from the prior owner(s) party that induced the restriction initially. A mare designated MG is not eligible to produce registrable offspring. If the restricting party is deceased or mentally incapable of decisions, the NFHR can be petitioned by the current owner to reinstate breeding rights, at the discretion of the BOD. There is no fee for this service.

Attachment 3

ARTICLE V - TRANSFER OF OWNERSHIP

Before a change of ownership can be recorded by the Norwegian Fjord Horse Registry, the following must be received by the Registrar:

A. The original Registration Certificate or an official NFHR Duplicate Certificate.

B. The transfer report located on the back of the Registration Certificate signed and completed by the seller or sellers (if jointly owned.) If the original certificate is the old style that does not have the Transfer Report on the back of the Registration Certificate, then use the Transfer Report form found on the NFHR website.

C. The correct transfer fees must accompany the transfer request.

D. All ownership history must be recorded, however, in the event there is a gap in ownership for geldings, the Registrar reserves the right, through other means of proving ownership for the gap, to record only ownership where proof is provided.

NFHR Board of Directors (BOD) Communication Policy

- 1. Individuals NFHR members should be encouraged to email the BOD with their questions, comments or concerns. Discussions via other sources, such as social media messaging, should be discouraged.
- 2. When an individual NEHR member sends an email to a BOD member or the Registrar, the entire BOD should be sent the request via copying the listserve email (if the individual member did not copy all BOD members).
 - a. If tracking communications, record the details in the designated communication tracker (date of receipt, sender name, email summary, target response date, category, etc.).
 - b. An email from a board designee will respond within two (2) business days that 'we have received your inquiry and will provide a response after the next BOD meeting' should be sent out. The president or his/her assignee, will respond if all board members are copied. If an individual BOD member is sent a message, that BOD member will respond with a receipt notification.
- 3. After a response is agreed upon by the whole board, the board designee will send the board-approved response, or the next steps, to the individual member, and the BOD will be copied on the response.

- a. This response should be provided within 1-2 weeks of receipt of the original message; if possible. If an extended timeline is needed due to the scope of the email or board meeting schedule, an updated timeline will be provided to the individual member.
- 4. If a phone call for clarification is more efficient and effective, the call shall be summarized for the BOD, with a copy to the individual member to ensure the discussion was appropriately represented in the summary. If further action is needed, this will occur at the next BOD meeting.
 - a. If tracking communications, record the details in the designated communication tracker (date of receipt, sender name, email summary, target response date, etc.).
- 5. Individual board members should not claim to be able to make decisions for the rest of the board.
- 6. Individual board members should not discuss any board business with non-board members other than what is presented to the membership through BOD minutes, mail, the Herald or any other board approved source.
- 7. BOD e-mail communications will be considered confidential and stamped as such using an email signature. "For Addressee Only"
