- Executive Director report- Jeanne

- In the past month, our foal registrations increased by 15 foals. Transfers increased by 17. The registry's cash flow continues to thrive, and I accredit our registrations and transfers to this. People are still breeding and selling fjords. At the moment, we have no active fund raising happening. We do offer promotional items.
- I will reiterate my ED note from last month, this board has done very little with obtaining the goals we set at the January Face 2 Face meeting. The only goal that was attempted has been our promotion committee, and now, due to frustration, our chair of that committee has resigned. These goals have not been revisited, nor discussed since January. If this board feels these goals are unattainable, we should discuss and rescind what we voted on in the F2F meeting, and possibly set new goals worth working towards.

Membership announcement for electronic voting being delayed to 2026:

The NFHR has postponed electronic voting until the 2026 Board of Directors election. The board determined that a more in-depth review was required before rolling this change out to the membership.
